## 4. GENERAL CONDITION

- The quoted Prices are to be inclusive of all taxes levied by the Government. PLEASE ENSURE COMPLETION OF “ANNEX-A” AS PER THE GIVEN FORMAT.
- The firm should be registered with FBR having income tax and sales tax certificates. The firm should be on active tax payer list, as per KPPRA Rule 8(3) (b).
- Bidder should provide Company Booklet or Brochure of the quoted item on the basis of which Technical evaluation will be conducted.
- Technical Department of KPOGCL will evaluate/verify the product, on their confirmation payment shall be process.

- e) Defective, refurbished and substandard Batteries will not be accepted and returned to the suppliers for replacement with new and same specifications.
- f) Item(s) are required on immediate basis (Not later than 15 days) after issuance of Purchase Order.
- g) Bidder shall be responsible for warranty/Guarantee etc.
- h) Interested firm should have regular place of business, telephone number, email address and must provide proof of their existence in the particular business.
