Procurement Committee Remarks.

The Committee, after detailed evaluation of the bids received against **Tender No. KPOGCL/Tender/579/2026**, observed that the participating bidders did not fully adhere to the mandatory bid submission instructions and other requirements given in the Tender Notice and the General Conditions of the Bidding Documents.

Since the bidding documents require submission of proposals through the prescribed portals and further provide that the KPOGCL may reject bids that do not adhere to the prescribed instructions, the Procurement Committee is of the considered opinion that the present procurement process has not resulted in a fully compliant responsive bid.

Accordingly, the Committee recommends to the Competent Authority that the procurement proceedings may be rejected and the tender may be re-invited under the applicable provisions of the KPRA Rules and the Bidding Documents.

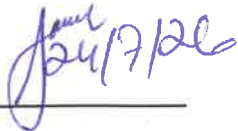

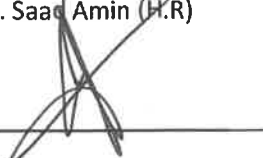
